5.2.1 Discussion and possible action on personnel matters involving: the appointment or employment of an Executive Director candidate.

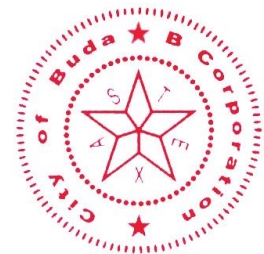
6.0 ADJOURNMENT
