- 4.1 Discussion and possible action regarding the employment of an executive director

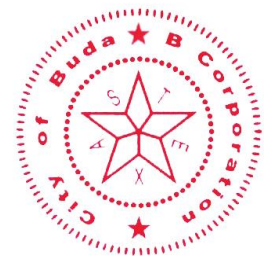
5.0 ADJOURNMENT
