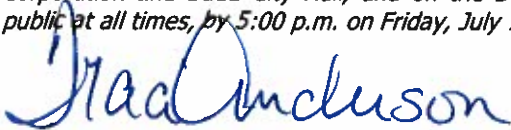
## I. ADJOURNMENT
